

Fees under the Dentists Registration Ordinance (Cap. 156)

Following the passage of the Dentists Registration (Amendment) Bill 2024 at the Legislative Council on 10 July 2024, the relevant amendments will come into operation on the day(s) starting from 1 January 2025 to be appointed by the Secretary for Health by notice published in the Gazette.
